## **Application Requirements**

- 1. Applicants must be at least 18 years of age
- 2. Current and valid Driver's License or Identification Card
- 3. Copy of Social Security Card
- 4. Income must be at least 3 times the amount of rent per month
- 5. Proof of Income, such as (2) current pay stubs & the Name, Address and Phone Number of the current employer or organization from which payments are received.
- 6. Current Award Letter of Benefit such as Social Security or Pensions.
- 7. Current Notice of action AFDC or TANF
- 8. Self-Employment will be verified by the previous **year's Income Tax Schedule C** or by accounting records for current year
- 9. Provide previous <u>2-years</u> of Rental/Residence history with Names, addresses and phone number of previous Landlord or Property Management Company
- 10. Credit Report with outstanding collections **exceeding \$1500.00** within the past <u>2-years</u>, negative rental references, or any convictions for violent crimes could be basis for Application Denial. (**Note**: If the Denial was partially or fully due to credit history, an adverse action Notice will be provided to the applicant)
- 11.Rental application must be complete when submitted with all applicable information as requested, or may not be processed.
- 12. \$25.00 Non-Refundable processing fee per EACH APPLICANT
- 13. Application may be subject to Owner's approval
- 14. Property availability is subject to change: **PLEASE VERIFY** with our staff that the unit is still available prior to submitting your application as well as your application fee.
